We irrevocably confirm that no term, condition or statement in the Report limiting or restricting (a) reliance by third parties or assignees and (b) use or copying of the Report shall apply or be valid as between the Beneficiary and us and any such clauses shall be deemed deleted.

We undertake not to preclude the Beneficiary from recovering any losses from us by reason that:

- 1. the acts or omissions causing those losses occurred before the date of this Reliance Letter and/or
- the Company will not incur or has not or would not have incurred any such losses 2.

provided always that the duties, obligations and liabilities we owe to the Beneficiary in relation to the Report pursuant to this Reliance Letter are no greater in scope or duration than those we originally owed to the Company.
